Thanks for your email. and I have discussed it. We would offer this explanation.

The phrase 'parish affair' is not defined in the Local Government Act 1972. Case law suggests it was undefined on purpose so as to include anything which is of interest to those in the parish. While Marlow Town Council may not be the statutory consultee, this does not prevent Marlow Town Council commenting. The application can be reasonably construed as a parish affair, the development being likely to affect the town in some material way e.g. in terms of traffic, employment and services. The degree of public interest in Marlow about the planning application suggests that the application is indeed of interest to the community. It would be odd if the residents of Marlow were unable to comment on the application - through its Parish Meeting or the Town Council – by virtue of the latter not being a statutory consultee.

The National Association of Local Councils describes a parish affair as "any local issue, activity, subject matter which specifically affects a particular parish and which a parish meeting may wish to discuss, debate and potentially influence. It excludes matters which affect all parishes in the country equally."

The decisive factor is that the parish affair should *affect* the parish. The limitation is where the subject is a general one which does not specifically *affect* the parish. Here it is reasonable to assume that the development will 'affect' the town of Marlow in some material way. As such, the parish meeting was able to discuss it and a poll is legitimate.





Before the determines whether the polls should proceed, it would be useful just to clarify a couple of procedural questions, having reviewed the notes of the meeting and the recording Procedural steps in generating a poll question are: 1. The demand for the poll is made with the consent of or at the request of 10 or one third of the electors. Once the poll has been validly demanded there is no vote on whether the poll should take place; 2. The question giving effect to each poll needs to be approved by the majority present At certain points in the recording it appears to be said that the wording of the question needs to be agreed by 10 or a third of the electors, which is not the case. We need to be clear that each poll was validly demanded (by approved by a majority of those present. It would be very helpful if you could contain that this was the case for each poll – by reference to the point in the recording if possible. This is particularly the case for those questions citing FOI and the greenbelt. At 1 hour 05 minutes in the recording, four polls are noted as having been agreed (three calling for resignations, one as to whether the film studios should be built). Shortly thereafter, the meeting appears to call 10 people together (it's unclear from the recording and notes whether any other electors remained present). Then at 1 hour 37 minutes, the amounces the wording of the "first three polls" and then outlines them citing the FOI outcome as evidence for resignation, it is not clear who or how many people determined that wording. The has received a notification from Marlow Town Council confirming that a parish meeting was held on 8 April 2024 and that you presided at the meeting. At the meeting Polls were called for and the wording of the questions for the poll agreed by more than a third of the electorate that were present in the room each time.

The has therefore reviewed the information provided, including the questions requested for polling, and has concluded that two of those questions satisfy the legal criteria for proceeding to a poll as set out in Schedule 12 of the Local Government Act 1972 and case law. However, a number of the questions do not fulfil the required criteria, and therefore will not proceed to a poll. An explanation of this decision, and the next steps for this matter, are set out below.

Requirements for a poll to proceed

Parish poll questions must be clear, unambiguous, and capable of producing a "yes" or "no" response only. The questions should relate to a parish affair. Additionally, case law has established that the Returning Officer may not grant a poll where its purpose is devoid of practical application.

The following two questions fulfil this criteria and will therefore proceed to a poll.

- 1. "Do you wish Marlow Film Studios to be built?"
 - Proposer,
- 2. "Do you want development in the greenbelt on the scale proposed by the Marlow Film Studio?"

The following questions (numbering added for ease of reference) will not proceed to poll and the reasons for this are set out below:

3) "Do you think that the following Councillors should resign Cllr Stapley, Cllr Scott, Cllr Funnell?"

Proposer.

As a 'poll question' this is devoid of practical application, and therefore does not meet the required criteria. This is because neither the parish council nor the parish meeting can make the outcome of the proposed question happen. A resignation is the personal choice of a Councillor. A Councillor resigns by handing a notice to the Chairman of their Council. It is not within the power of a parish council or parish meeting to request a Councillor resignation. The question as worded is not the same, for example, as a request for a vote of no confidence by the Town Council.

However, the resolution of the parish meeting can be passed on to the Town Council or to the three Councillors as an expression of opinion from that body.

- 4) Facts obtained by FOI show that Cllr Scott has not acted with integrity, accountability and openness and therefore should resign, do you agree?
- 5) Facts obtained by FOI show that Cllr Stapley has not acted with integrity, accountability and openness and therefore should resign do
- 6) Facts obtained by FOI show that Cllr Funnell has not acted with integrity, accountability and openness and therefore should resign do you agree?

Similarly, the three questions above are also devoid of practical application, and therefore do not meet the required criteria. The Town Council can't conclude that the Councillors have failed to meet these Code of Conduct requirements; only Buckinghamshire Council can do that through the complaints process; and those councillors have not been found in breach of the Code. The questions are not a fact, nor something the Town Council can determine. Consequently, the questions could be also potentially libellous.

Next Steps

The will now determine the date of poll for questions 1) and 2), and give notice to the proposer of the questions once a day of poll is set. This will depend on the polling place availability (6 polling places are likely to be required) and timescales required for organising the

poll. You will be aware of the national election taking place on 2 May 2024 to elect the Police and Crime Commissioner for Thames Valley area. Parish polls cannot be combined with other polls, and therefore this date is not available.

Those motions passed at the parish meeting and agreed by the (questions 1) and 2), will be reproduced as the questions on the ballot paper. There can be no further changes made to the wording as once the questions have been agreed at the parish meeting they cannot be changed.

The local government electors in the parish area of Marlow Town Council will be polled. Polling hours are 4pm until 9pm on polling day. There is no provision for poll cards to be sent for parish polls. Marlow Town Council will be provided with a copy of the Notice of Poll. The cost of running the poll must be recharged to the parish council. We estimate the cost of running this poll be to be around £5,300. The result of the poll is not binding, but may provide an indication of support for or opposition to specific local matters.







The has received a notification from Marlow Town Council confirming that a parish meeting was held on 8 April 2024 and that you presided at the meeting. At the meeting Polls were called for and the wording of the questions for the poll agreed by more than a third of the electorate that were present in the room each time.

The has therefore reviewed the information provided, including the questions requested for polling, and has concluded that two of those questions satisfy the legal criteria for proceeding to a poll as set out in Schedule 12 of the Local Government Act 1972 and case law. However, a number of the questions do not fulfil the required criteria, and therefore will not proceed to a poll. An explanation of this decision, and the next steps for this matter, are set out below.

Requirements for a poll to proceed

Parish poll questions must be clear, unambiguous, and capable of producing a "yes" or "no" response only. The questions should relate to a parish affair. Additionally, case law has established that the Returning Officer may not grant a poll where its purpose is devoid of practical application.

The following two questions fulfil this criteria and will therefore proceed to a poll.

1.	"Do you wish Marlow Film Studios to be built?"
	Proposer,

2. "Do you want development in the greenbelt on the scale proposed by the Marlow Film Studio?"



The following questions (numbering added for ease of reference) will not proceed to poll and the reasons for this are set out below:

3) "Do you think that the following Councillors should resign Cllr Stapley, Cllr Scott, Cllr Funnell?"

As a 'poll question' this is devoid of practical application, and therefore does not meet the required criteria. This is because neither the parish council nor the parish meeting can make

the outcome of the proposed question happen. A resignation is the personal choice of a Councillor. A Councillor resigns by handing a notice to the Chairman of their Council. It is not within the power of a parish council or parish meeting to request a Councillor resignation. The question as worded is not the same, for example, as a request for a vote of no confidence by the Town Council.

However, the resolution of the parish meeting can be passed on to the Town Council or to the three Councillors as an expression of opinion from that body.

- 4) Facts obtained by FOI show that Cllr Scott has not acted with integrity, accountability and openness and therefore should resign, do you agree?
- 5) Facts obtained by FOI show that Cllr Stapley has not acted with integrity, accountability and openness and therefore should resign do you agree?
- 6) Facts obtained by FOI show that Cllr Funnell has not acted with integrity, accountability and openness and therefore should resign do you agree?

Similarly, the three questions above are also devoid of practical application, and therefore do not meet the required criteria. The Town Council can't conclude that the Councillors have failed to meet these Code of Conduct requirements; only Buckinghamshire Council can do that through the complaints process; and those councillors have not been found in breach of the Code. The questions are not a fact, nor something the Town Council can determine. Consequently, the questions could be also potentially libellous.

Next Steps

The will now determine the date of poll for questions 1) and 2), and give notice to the proposer of the questions once a day of poll is set. This will depend on the polling place availability (6 polling places are likely to be required) and timescales required for organising the poll. You will be aware of the national election taking place on 2 May 2024 to elect the Police and Crime Commissioner for Thames Valley area. Parish polls cannot be combined with other polls, and therefore this date is not available.

Those motions passed at the parish meeting and agreed by the questions 1) and 2), will be reproduced as the questions on the ballot paper. There can be no further changes made to the wording as once the questions have been agreed at the parish meeting they cannot be changed.

The local government electors in the parish area of Marlow Town Council will be polled. Polling hours are 4pm until 9pm on polling day. There is no provision for poll cards to be sent for parish polls. Marlow Town Council will be provided with a copy of the Notice of Poll. The cost of running the poll must be recharged to the parish council. We estimate the cost of running this poll be to be around £5,300. The result of the poll is not binding, but may provide an indication of support for or opposition to specific local matters.
